PARENTS PLEASE READ

Thank you for expressing an interest in the Buckeye Chippewa Youth Shooting Sports. The purpose is to introduce youth to the shooting sports – trap and sporting clays - with an emphasis on safety, sportsmanship, and fun. Youth from elementary grades through high school are eligible to participate. Our program is designed for youth who have never handled a firearm to those who shoot on a competitive basis. NRA/SCTP certified coaches will be present at all times.

Our organization, Buckeye Outdoors Youth Education & Shooting Center (BOYESC), provides other programs for outdoor interested youth and their families. In addition to our shooting sports, BOYESC offers an Archery Program with different skill levels and a Bird Hunting Program with different phases. We also participate in the Lake & Trails Program and the Ohio Sportsmen Farmers Youth Day.

For our youth shotgun program, we will begin on Monday, March 25th for all first-year shooters with a mandatory classroom instruction at the OSFL clubhouse,1755 Jacoby Rd., Copley @ 6 pm.

Trap – 8 weeks begins Monday, April 1st through Thursday, May 23rd

- The fee to participate in the Trap program is \$150 (\$175 after March 16th). The fee includes instruction, targets, shells and hearing protection. In order for your youth to participate in any shooting instruction please return <u>all signed</u> registration forms, consent forms, and fees no later than March 16th, preferably earlier. Completed packets can be turned in at the range, registration meetings or mailed. Registration packages received after March 16th incur an additional \$25. Financial grants are available for those that need assistance. Contact Tina Marshall.
- **New first year shooters** will begin on Monday, April 1st starting at 5pm. All new shooters will then shoot on Monday, April 8th starting at 5pm and all experienced shooters on Thursday, April 4th. Exceptions may be made.

Sporting Clays – 10 weeks begins on Wednesday, April 10th through Wednesday, June 12th

Program is designed for experienced clay shooters wanting additional training in another shotgun discipline. Participation
is limited. The fee to participate in the Sporting Clay program is \$450. Financial grants are available for those that need

Our organization is operated with an all-volunteer team of adults and youths. As we have grown more help is needed, Adults, please consider volunteering in some manner. If everyone does one job/responsibility, and does it well, we will continue to improve and provide a quality shooting program. We strongly encourage all youth who take part in our program to work 2 days at the range on Saturdays. They will be under direct adult range staff supervision. A calendar will be available at the range.

Finally, it is a <u>privilege</u> for your youth to participate in the Buckeye Chippewa Youth Shooting Sports. Each shooter and their parent(s) will act responsibly and respectfully. No horseplay, safety violations, or rules/sportsmanship violations will be tolerated, and will be grounds for removal from the club. Fees will not be refunded in the event a youth is removed because of inappropriate actions.

Read and sign (where needed) all paperwork within this packet and return signed papers to the range, a listed coach, or mailed to: BOYESC, PO Box 61, Doylestown, Oh., 44230 before March 16, 2024 to avoid the additional \$25.00 late fee.

FREQUENTLY ASKED QUESTIONS

FIREARM QUESTIONS

- Q: Do we need to have our own shotgun?
- A: No. We have numerous club shotguns you can use until you decide to purchase your own. One occurring problem we have is that more than one shooter may be using the same shotgun. Having your own shotgun eliminates the problem
- Q: What gauge shotgun should I use?
- A: 12 gauge is the most popular gauge and is the preferred choice if the shooter can handle the weight and the recoil. 20 gauge is best suited for our smaller or younger shooters due to the lighter weight and sometimes less recoil.
- Q: What choke should I use for trap?
- A: Full, improved modified, or modified is common
- Q: What type (action) should I get?
- A: A quality shotgun can be either a hammer-less single shot hinged action, pump action, semi-auto, or an over and under. Check with your Lead Coach for a recommendation if you are planning on buying a shotgun. Some shotguns will not stand up to the large amount of rounds fired during a trap shooting season

RANGE QUESTIONS

- Q: Are there any additional fees or cost to shoot? Do I need to pay for anything else?
- A: No, your original fee pays for all your shells and targets during our 8 week program. You will need to buy a shell pouch and safety/shooting glasses and have them the first shoot.
- Q: When do I shoot?
- A: You will sign up for a preferred time on your designated night at one of the registration meeting nights. This will be Monday nights for new shooters and some experienced shooters. Our more experienced shooters will shoot on Thursdays.
- Q: Where do I go and what do I do on my scheduled League practice night?
- A: Upon arrival, go to the clubhouse to sign in and receive your shells. THEN:
 - *Look for the reader board and see which trap house you will shoot at
 - *Go to the appropriate trap and sign-up for your assigned time slots (2)
 - *Be prepared 15 minutes prior to your shoot time. (Gun ready, eye & ear protection)

- Q: How do the time slots work?
- A: Shooters begin at 5:00 PM, 6:00 PM, and 7:00 PM, shooting ends at 8:00 PM or sunset. Make sure you are on time and ready to shoot. You have a designated 1 hour time slot to shoot 2 rounds of trap or your 50 shells. We stop on the hour. Beginning/ new shooters should not expect to shoot all 50 shots a night due to individual instruction and safety concerns.
- Q: Will I get to finish my 50 shells later?
- A: Yes, possibly that night, if time allows and does not affect another shooter's assigned times. They have 1st priority. Otherwise you can make them up on a Saturday
- Q: Will we shoot if it is raining or windy?
- A: Yes. Generally, the only time we do not shoot is if lightning is seen. Then we will wait for approximately 30 minutes. Should we not complete shooting that night, another night will be designated as make up.
- Q: Who should I call if I have a question?
- A: Call your Lead Coach, his/her phone number is listed in this packet. Please call after 5 PM as most coaches work or Tina Marshall on 330-461-1465.
- Q: Are there any other communications I should be aware of?
- A: Yes. I will send emails as my primary form of communication. CHECK YOUR EMAIL REGULARLY: "I DIDN'T CHECK MY EMAIL" IS NOT A VALID EXCUSE. You may want to team up with other parents with the same time slot so you can contact them about any recent communications, as your youth's Coach will be extremely busy on shoot nights

NOTE: You will shoot at your designated day and time unless cleared with your coach prior to your designated day.

PARENTS & ATHLETES - PLEASE READ CAREFULLY

- 1. Athlete acknowledges that the BOYESC is a team-based program that provides TEAM practices and competitions(optional) in trap & sporting clays which involves the use of firearms. Athlete further acknowledges that BOYESC emphasizes and REQUIRES the SAFE HANDLING and USE of firearms at ALL venues and/or locations where firearms are present. Failure to adhere to this requirement may be grounds for removal from BOYESC.
- 2. Athlete requests to participate knowing and understanding that there are risks and dangers associated with the use of firearms, including serious bodily injury, death and property damage. Athlete agrees to assume all risks, inherent or otherwise, that may occur due to, arise out of or be in connection with Athlete's own participation, including without limitation the risk of serious bodily injury, death and property damage. Athlete further agrees to assume all risks, inherent or otherwise, that may occur due to, arise out of or be in connection with the participation of others in the BOYESC program, including without limitation to instructors / coaches; staff or volunteers of BOYESC, SSSF, SCTP Sponsors,or the Governing Bodies; and audience members. NOTE: Please be advised that it is not possible to list all of the activities and related risks that Athlete may encounter by participating in the BOYESC program. There may be risks that are not known to Athlete, or to other athletes of the BOYESC, including staff or volunteers of BOYESC, SSSF, SCTP Sponsors or the Governing Bodies, and may not be foreseen or reasonably foreseeable by anyone at this time or at the time of the activities in which Athlete participates. Athlete agrees to assume all risks of serious bodily injury, death and property damage, and all other risks of participation with BOYESC, whether or not described to Athlete. Athlete understands that there are risks and dangers associated with the use of firearms, including serious bodily injury, death and property damage that may occur due to, arising out of or in connection with Athlete's own participation or the participation of others with BOYESC.

Scholastic Action Shooting Program 2023-2024 Sportsmanship Contract

The Scholastic Action Shooting Program (SASP) places a strong emphasis on sportsmanship and safety. As part of this effort, parents/guardians are asked to read and discuss the elements of this Sportsmanship Contract with their child athlete. This is a contract between the Scholastic Shooting Sports Foundation and the parent/guardian and his/her child. The signatures on this form signify agreement to comply with the provisions of this contract.

SPECIAL NEEDS MEMBERS GUIDELINES/AGREEMENT

As the popularity of the shooting sports increases, we recognize the desire of youth with special needs wanting to participate. We realize, however, that there may be limits to what a youth can capably handle physically, emotionally, or mentally, and have established guidelines to allow participation with some limitations. The Head Coach

and Assistant Coaches of Buckeye Outdoors Youth Education are the authorities on what can be safely done by an individual. Each member will be individually assessed, and recommendations will be made for participation. If a youth is physically unable to handle a shotgun or bow due to physical size or handicap, he or she will be deemed unable to participate in the actual shooting. The youth will be able to work on other related aspects of that discipline, if desired. This pertains to all special needs such as ADHD, autism, emotional disorders, learning disabilities, etc. If during the course of the program year it becomes apparent that changes need to be made to the member's participation criteria, that will be done at the discretion of the Head Coach and Assistant Coaches and communicated to the parent or guardian.

Parent/Guardian Agreement Acknowledgement

Understanding that, due to the nature of the shooting sports and the inherent possibility of human error leading to injury, I accept the decision of the coaches in limiting the participation of my youth. I accept that this decision is in keeping with state requirements and laws governing special needs individuals and is to ensure the enjoyment and safety of my youth and all members and participants of this program.

Principles, Policies, and Fundraising Guidelines for Tax Deductible Donations to Buckeye Outdoors Youth Education and Shooting Center, Inc. d.b.a. Buckeye Chippewa Youth Shooting Sports ("BOYESC") Effective 1/1/2016

Principles

- To maximize the positive impact and outreach of BOYESC's programs through all donations
- To be knowledgeable of, and adequately compliant with, IRS rules & regulations, as well as known best practices, to support the tax deductibility of donations entrusted to BOYESC by donors
- To consider restrictions and preferences expressed by donors to the extent allowable and practicable

Policies (Numbered for reference only)

- 1. Tax Deductibility per IRS: For a donor to be eligible for a tax deduction, the donor's intent must be to benefit the organization rather than an individual, and the organization must be allowed full control of the donated funds and full discretion over their use. To ensure deductibility, BOYESC will require all fundraising solicitations to include the following language:
 - a. "This contribution is solicited with the understanding that the Board of Directors of
 - b. BOYESC has complete control and discretion over the use of all donated funds."

Further, it is the policy of BOYESC that this be conveyed to the donor before a gift is made, at the point of solicitation, whether the solicitation is verbal or written or both. This language will also appear on contribution acknowledgments.

- 2. Qualified Public Charity: BOYESC is a non-profit corporation and has been determined by the Internal Revenue Service to be tax-exempt as a 501(c) (3) public charity. Tax-deductible contributions must be irrevocable; therefore, all donations are non-refundable and non-transferable.
- **3. Unrestricted and Restricted Donations:** BOYESC gratefully accepts contributions and sponsorships to support our youth outdoor programs. We recognized the desire by some donors to restrict the use of their donations to specified purposes (i.e. Legal Fund, Memorial Fund, etc.). Restricted donations are used to support the purpose for which they were originally intended until that purpose has been satisfied. After which, any excess funds are used to further the outreach of BOYESC.
- 4. Applicability of Donor Restrictions: Unless donor restrictions are specified, donations will be considered available to impact every aspect of BOYESC outdoor programs. When a donor explicitly states an intention to restrict donations to a specific purpose, BOYESC uses all reasonable efforts to follow the donor's intent. However, a donation restricted only for the personal benefit of, or use by, one individual would not be tax deductible and therefore such restrictions cannot be accepted. Instead, donors may express a preference that the donation be used toward a particular purpose and thereby support a particular fundraiser's or other individual's participation with BOYESC in accomplishing that purpose.
- 5. Fundraising: Youth participants and their families may raise donations to support specific purposes and programs approved by the BOYESC Board of Directors. If a donor wants to make a charitable contribution to BOYESC with preference to the support of a specific youth participant of its many programs, the donor must use the Donation Request Response Card; the individual cannot be preferenced (written on) on the donor's check.
- 6. Fundraising Intended Benefit and Discretion and Control: By preferencing a contribution toward the support of a BOYESC participant or program, it should be understood that the charitable contribution is made for the benefit of BOYESC for use toward Board-approved expenditures of the participant or programs. BOYESC will maintain control over the contributed funds and exercise full discretion over the use of all tax-deductible contributions, without any obligation to directly benefit the fundraiser or any other individual. Accordingly, it is not acceptable for tax-deductible contributions raised by a fundraiser to be set aside to reimburse expenses incurred by, or applicable to, only one individual fundraiser or participant.
- 7. Fundraising –Withdrawal of participation: When a BOYESC project or program is completed, or when a participant withdraws from participation for any reason, all unspent contributions remain the property of BOYESC. Unspent account balances will not be turned over to the person who raised the funds or returned to donors. Remaining support balances when a participant separates from BOYESC will be transferred to the general fund.

8. Fundraising — **reporting**: Donations expressing a preference for a particular participant are accumulated in a fundraising summary for informational purposes only. Such reporting should in no way be interpreted to indicate that the fundraisers or donors may exercise any rights to or control over the gross or net amounts reflected in the fundraising summaries

Fundraising (FR) Guidelines

In order to keep participants' costs manageable for all families, BOYESC strives to provide many fundraising opportunities so that every participant can fully participate in at least one fundraiser. FR includes, but is not limited to, corporate and individual donors, multiple types of raffles, name-brand fundraisers, and range staff opportunities.

Corporate/Individual Donor: 100% of all donations are made payable to BOYESC can preference up to 90% of their BOYESC donation to participants via the Donation Request Response Card. Per IRS guidelines all checks must be made out to BOYESC and cannot include the name of the youth participant. BOYESC will maintain control over the contributed funds and exercise full discretion over the use of all funds.

<u>Raffles:</u> The majority of raffle proceeds are used to provide discounted targets and shells, awards and event food for all youth participants; all funds raised from these raffles go directly to the general fund or are forwarded to our Midway Endowment Fund. Our annual reverse raffle is the exception, \$10 of each ticket sold by a participant's family will be placed directly into the fundraising summary report; 100% of donations of baskets and items for the raffle will be placed directly into the fundraising summary;

<u>Uses of FR monies:</u> Monies placed into the fundraising summary report can only be used for expenses directly related to BOYESC activities (listed below) and must be approved by the BOYESC Board of Directors. Under no circumstances can the funds be used to reimburse expenses incurred by, or applicable to, only one individual fundraiser or participant or for purposes not consistent with BOYESC' mission statement.

The list is as follows:

- BOYESC Activity registration fees (includes costs of uniform)
- Practice shooting at Copley Range (targets, shells used on premises only)
- Buckeye Chippewa/BOYESC SCTP Team Competition/Practice fees (Fees include targets and shells.) **Note:** under no circumstances can FR be used for Competition/Practice fees, shells or targets when competing as an *individual* at a trapshooting or sporting clays event (i.e. Zone, Buckeye, State, Grand, etc.).
- Registered shoots held at Copley Trap Range (ATA/OSTA fees, targets, shells used on premises only)
- ATA/NSCA membership for youth
- Shooting supplies provided/ordered by BOYESC
- Copley Range sponsored leagues (league fees, targets, shells used on premises only)
- Other BOYESC-sponsored activities (archery, bird hunts, Lake & Trails, etc.)

**The Board of Directors of BOYESC has complete control and discretion over the use of all donated funds and reserves the right to change these policies as it sees fit to benefit the group as a whole. All decisions will be final.
